

SOL PLAATJE UNIVERSITY RESIDENCE RULES

The following residence rules must be read in conjunction with the Policy on Residences. These rules to apply to University and Private residences and may be adopted by owners in off-campus accommodation.

1. Residence Admission

- a. Admission to residence accommodation is for one year only
- b. Residence allocation is carried out by the Residence office only
- c. No student is allowed to change the residence and room allocated to them (Refer to Residence Allocation Procedure and Policy on Residences)
- d. A student whose academic progress is unsatisfactory may be refused readmission to residence the following year.

2. Period of Accommodation

- a. The regular period of accommodation is from the one day before the start of the first semester until the last day of the mid –year examination and the day before the start of the second semester until the last day of final examinations.
- b. Students are required to vacate the residence 48 hours after their final examination.
- c. Students writing supplementary examination will be allocated a residence to reside in during supplementary examinations.

3. Visitors

- a. All visitors must be signed in by the host
- b. Visitors must produce their cards if they are student's, identity document or drivers' licence if not students.
- c. All visitors must leave the residence by no later than 22:00 on weekdays and 24:00 during weekends.
- d. No visitor is allowed to sleep over in a residence.

4. Alcohol and Drugs-

- a. No alcohol is allowed in any of our residences.
- b. Students are not allowed to keep alcohol in their rooms.
- c. No drugs are allowed in any of our residence. This includes keeping, selling or using dagga\cannabis.

5. Smoking

- a. Smoking is not allowed in any of our residences
- b. Smoking is only allowed in designated smoking areas.

6. Furnisher and Appliances

- a. Students are not allowed to move, remove or swop furnisher in their rooms.
- b. Students are not allowed to bring their own refrigerator, microwave, stove or heater.

7. Damage to Property

- a. An inventory will be conducted before students move in and when students move out.
- b. Students will sign the inventory document that specifies furnisher and the condition of the furnisher in the room.
- c. Students will be held liable for any damage if there is proof that the student damaged the property.
- d. Students must report any wear and tear in their rooms via the Help desk immediately.

8. Noise Levels

- a. No student is allowed to make noise that will negatively affect other students.
- b. No loud music is allowed in the residence that negatively affects other students.

9. Fighting and Disorderly Conduct

- a. No fighting is allowed in any of our residences.
- b. No student is allowed to act in a manner that will create disorder and disturb other students.

10. Threatening and Intimidation

a. No student is allowed to threaten or intimidate other students.

11. Pregnant Students

- a. The University does not have skills and resources to deal with pregnant students in our residences. (Refer to the Procedure for pregnant students in Residence)
- b. A student must notify the residence warden about the pregnancy and the stage of the pregnancy after confirming the pregnancy.
- c. A student must consult the Health and Wellness Centre to get information on how, when and where to register for an Antenatal programme.
- d. Pregnant students are required to move out of residence when they are 7 months pregnant.
